Q9

The Moderately Priced Dwelling Unit (MPDU) program requires that at least 12.5% of homes in a new residential development with at least 20 homes be set aside as affordable homes. The cost of doing so is paid by a project's developer. Because the number of MPDUs is tied to the number of total units, the larger a development is, the more MPDUs will be built. Conversely, if the initial density proposed by a developer is reduced during the approvals process, rather than maintained or increased, fewer MPDUs will be built. Planning Board commissioners are likely to hear from some constituents concerned by a project's potential impact—real or assumed—on traffic, parking, views, and property values and rents, and whether it fits the character of the neighborhood. If a development with MPDUs came before you, what would you do, given the likelihood of at least some pushback?

I would encourage developers to limit the height and density of the project.

Q12

How will you ensure that the County produces housing for residents who make between 50% AMI and 80% AMI?

Page 6: Transportation

Q14

Q23

In your own words, could you describe what this data means for the Planning Board as it makes decisions in the future?

The Data for Progress study establishes that there is substantial support (overall, 61%) among likely Democratic voters in Montgomery County for supporting denser residential construction in their own neighborhoods. Support is most pronounced among voters aged 45 or below, current renters and the college educated.

At the same time, significant percentages (overall, 32%) of likely Democratic voters oppose added density. Opposition is most pronounced among those without college educations, Black voters and homeowners.

These data reinforce current understanding that the creation of additional housing opportunities is a top priority for the Planning Board.

Equally important is the need to conduct additional, granular research and outreach to determine the housing needs and preferences of County residents overall and among demographic subgroups, as well as to understand the concerns of those who oppose added density.

Ideally, areas of shared agreement will be found that will increase the housing stock, enhance housing affordability, address racial equity and social justice concerns, promote transparency in land use decision-making and increase public confidence in the Planning Board and its work.
